An Annual Meeting Like No Other

Despite the challenges of the Covid-19 pandemic, GSRA successfully held the 2020 Annual Meeting virtually. Our by-laws require us to have an Annual Business meeting, nominating officers for next year, approving the annual budget and last year's Business meeting minutes, and a recap of the previous year by our President. The Annual Meeting Committee explored a number of options to make that happen, from a statewide Zoom meeting to a Facebook Live Board meeting. Ultimately, the logistics of such an undertaking were extremely challenging. Consequently we decided on a recorded ZOOM meeting of the Board, to be posted to the GSRA website on October 20 and a mechanism to allow members not only to view the video, but also vote on the items submitted for approval, as well as the slate of officers nominated for 2021. From 12 living rooms around the state, we accomplished our required tasks and more.

President Jim Sommerville thanked our membership for their support and patience during these trying times. Secretary Beverly Littlefield presented last year's minutes, Treasurer Harold Grindle presented the annual Treasurer's Report, including the Legal Fund Report, and Jim presented the slate of nominees for next year's Policy and Operations Board. Jim then gave a State of the Association address, summarizing our successes and our frustrations with not accomplishing more, despite our continued best efforts.

The virtual meeting also featured video updates from Jim Potvin and Danielle Templeton from Employees Retirement System, Frank Berry from Department of Community Health, and Christine Murdock from the Georgia House Budget and Research Office. GSRA thanks them all for their willingness to participate in the virtual Annual Meeting.

Of course, none of this would be possible without some help from our sponsors, in this case our Annual Partners: AMBA, Anthem, APCU and UnitedHeathcare.

The meeting was posted on the GSRA website and Facebook page on October 20, and all members have had a chance to view and vote on the reports and nominees. As of 10/24/20, 1572 members have read the email from GSRA Communications announcing the meeting, and 173 members have watched the video. The video will be available indefinitely, while the voting deadline was October 27th. Thanks to all who have viewed the video and voted.

Over the years, the very best part of the Annual Meetings has been the fellowship and connection with former co-workers and longtime friends. We certainly missed that this year. We also missed the opportunity to attend the always informative, interesting and fun workshops. The Annual Meeting committee is actively working to make that happen next year at Lake Blackshear Resort, a unique and beautiful location. Be looking for further details as we finalize plans. GSRA Updates Website and Membership Processes

The major changes that you will notice are a new look for the "home" page (<u>www.mygsra.com</u>) along with other website information and the membership renewal process.

You are encouraged to log-in to the website and view the changes. At minimum, make sure that you view the "home" page and click on the link to view the virtual annual meeting and recent news.

The "renewal" process for members having a valid email address consists of an expiration notice thirty days prior to the membership expiration date. If the renewal is not paid, you will receive notices at the 15th day and the 7th day before expiration. During the following six months, your membership is considered to be in a "grace period." Several notices will also be sent during this 6-month period.

Along with the expiration notice, you will receive an invoice. When you choose to pay, "click" on renew, choose the method of payment (credit card or check), "click" on "pay" and if paying by credit card complete your card information and "click". If, however, you are paying by "check", print the invoice (write your check) and send to the address on the invoice. When the invoice is "paid" including your check received, you will receive a notice via email.

Members who do not have a "valid" email address will receive a notice via the US mail with the attached invoice. The process is the same as that mentioned above for paying by check, except for the notices. Non-email notices will be mailed before the expiration date with a reminder being mailed in approximately two months if not paid.

Alternatively, you are encouraged to authorize the monthly deduction of \$1.67 from your retirement benefit (ERS retirees only), as this method is the most convenient for you overall and is GSRA's preferred method. This authorization allows you to sign one time and never get another renewal notice. (Note: If you choose to discontinue retirement deductions at some future date, you may do that by notifying GSRA.) If you choose to authorize the deductions from your retirement benefit, print the "Pension Deductions form", complete the form, be sure to legibly write your email address and your retirement number, and mail the form to GSRA at the address provided on the form.

Over 440 members have an incorrect email address with GSRA. It could be that the member signed up with a different email address or moved to an area where that service provider is not available. If you are not getting newsletters or other notices from GSRA, please log-in to your account and correct your identifying information.
