REPORT FROM THE GSRA LEGISLATIVE COMMITTEE

GSRA's legislative agenda was finalized last month. In addition, four related detailed proposals have been drafted for:

- Providing equity in benefits among the various state sponsored retirement systems and equity in pay increases among all state-funded employees,
- Creating a health benefits advisory committee for the Board of Community Health to review all pending policy decisions by the board and by department staff prior to their adoption,
- Providing retiree representation on the Employees Retirement System Board of Trustees, and
- Authorizing ERS to provide—upon approval of individual retirees—retiree contact information to GSRA.

We have begun scheduling meetings with legislators and/or their staffs to obtain support for our goals.

Budget Woes

As publicized in the news media, the General Assembly is struggling with continuing reductions in state revenues. This has apparently caused some members of the Senate Appropriations Committee to suggest an 'early retirement program' for state employees, with a goal of reducing their number by 5,000. Senator Seth Harp asked many department heads to provide the number of employees who are close to retirement (within two-three years of reaching 30 years of service).

The Senate Budget staff has estimated a savings of \$250 million. The 'early retirement' plan would exclude safety personnel. If such a program were to become law, both the Employees Retirement System and the State Health Benefit Plan would be significantly affected – not to mention the impact on the ability of State Departments to deliver essential public services. For example, Commissioner Rhonda Medows reported that a forced retirement as proposed would eliminate about 24% of central management of the Dept. of Community Health.

GSRA is extremely concerned about the impact of an early retirement program on the ERS and State Health Benefit Plan. Approximately two-thirds (67%) of the total projected salary savings (\$175 million) would immediately

be payable in pensions (\$120 million) from the ERS Trust funds each year. Adding 3,000 to 5,000 to the number of retirees in one year exceeds the normal projected growth of 800 to 1,000 each year. Reducing long-service employees by this number will also lower the compensation base on which employer and employee contributions are made, which would in turn result in a loss of approximately \$20.5 million in ERS revenues each year. The \$120 million additional payout, along with the \$20.5 million reduction in ERS revenue, will negatively impact the ERS Trust fund by at least \$140.5 million, not to mention the loss in annual investment income on the \$140.5 million. In recent months (before the 'early retirement' plan idea surfaced), the ERS Board of Trustees Chairperson reported that the ERS funded percentage may drop into the 75% range in FY 2011. Therefore, adopting an "early retirement' plan would have an even greater negative impact on the ERS retirement trust fund.

What about the effect on the SHBP? The benefit cost of the Plan would not decrease—only the employer payments into the fund would decrease since retirees continue SHBP coverage. Previous GSRA newsletters have reported continuing funding reductions to the SHBP and the planned use of ALL reserves, including the Incurred but Not Reported (IBNR) reserves. The revenue loss for the SHBP would be even greater than on the ERS Trust fund. Although the amount of reduction is not yet known, and DCH plans to convert State contributions to a dollar amount per actively covered employee on January 2011, the reduced state contribution would be at least \$31 million annually (18% of \$175 million). Therefore, an 'early retirement' plan will result in a need to dramatically increase SHBP funding

The bottom line: An 'early retirement' plan to reduce state spending may be futile if it results in much higher funding requirements for the benefit plans, which would in turn offset the cost savings. In addition, loss of knowledgeable staff could result in lawsuits in many areas, such as the Food Stamp Program, Medicaid, etc. An 'early retirement' plan is premature without consideration of all of the impacts on state programs and services that are essential for the citizens of Georgia.

2009-2010 GENERAL ASSEMBLY - BILLS OF INTEREST Updated through February 18, 2010

The General Assembly will not meet between February 18 and March 8, 2010. During these two weeks, the House and Senate Appropriations Committees are conducting budget hearings for the FY 2011 budget and waiting until the February State Revenue report is available.

ERS DISCONTINUES MAILING NOTICES WHEN PENSION CHECK CHANGES

With the recent change in retiree health insurance premiums, many ERS retirees have wondered why they never received an official itemized ERS notice detailing the change and showing the new net amount of their monthly pension. In response to GSRA members' questions, we asked ERS and have been advised that unless there is a Cost of Living Adjustment (COLA) that changes the gross amount of our benefit, no paper notice will be mailed. According to ERS staff, discontinuing these routine mail outs to retirees will save the ERS over \$17,500 each time in printing and So, if you change your tax withholding, or postage. the Federal or State tax withholding tables change, or health or dental insurance premiums change, no paper 'advice' (check stub) will be sent.

Instead of receiving a paper notice from ERS, you will need to access your account information by setting up an online account at www.ers.ga.gov, where you will be able to see your gross amount, and all deductions from your pension. Or you may call your bank to see if ERS has supplied enough withholding detail to pass along to you by phone. If neither of these options will work for you, ERS further advises that you may request a paper 'pay stub' by mail. PROPOSED HEALTH CARE REFORM AND MEDICARE ADVANTAGE PLANS

GSRA Leadership learned last month that national health care reform as proposed in Senate HR 3590 would specifically exempt seniors in certain Florida counties from funding cuts in Medicare Advantage Plans. Even with the current uncertainty surrounding the health care reform debate, we thought it important to make known our objection to this particular provision of the bill. Below is the text of the letter dated January 27, 2010 that was sent to Attorney General Thurbert Baker to express support of others' requests to look into the constitutionality of this part of the bill.

Dear Attorney General Baker:

The Georgia State Retirees Association (GSRA) thanks you again for your participation at our annual meeting last October. We very much appreciate your insightful answers to our questions at the roundtable discussion panel with other gubernatorial candidates.

Among those issues greatly concerning state and teacher retirees is the Department of Community Health's decision to discontinue all employer contributions to premiums for health insurance options other than Medicare Advantage Plans (MAPs) for all Medicare-eligible individuals who are enrolled in the State Health Benefit Plan. GSRA was gratified with your expressed position to restore choice for retirees. Until that occurs, however, GSRA is also greatly concerned with the current U.S. Senate HR 3590, Patient Protection and Affordable Care Act, and its dramatic cuts in funding for Medicare Advantage Plans for most seniors, but not for those seniors in specific counties in the State of Florida.

We know that the bill is still under discussion, but we understand that Senators Chambliss and Isakson, among others, have requested your opinion on the constitutionality of what would be unequal treatment of retirees who are enrolled in MAPs in different parts of the United States. GSRA wholeheartedly supports their request of your opinion and adds its request to that of the honorable U.S. Senators.

DCH Announces Regulation Changes for SHBP

The Department of Community Health has announced that a public hearing will be held on March 24, 2010 at 11:00 a.m. for the purpose of oral comments on proposed SHBP Rule changes. The notice and proposed changes are posted to the DCH website, www.dch.ga.gov.

Four Rules for Chapter 111-4-1 are proposed for amendment: Definitions, Organizations, Plan Benefits and Claims.

- **Definitions** are changed to reflect modifications in state law and administrative policy and to include definitions used in other proposed rule changes.
- The **Organization** Rule is changed to better reflect the revised billing process, to clarify that the SHBP shall be administered in accordance with federal law, to eliminate references to specific plan design terms, to clarify certain obligations of Employing Entities, and to clarify that any penalties or expenses arising from an Employing Entity's failure to meet those obligations may be assessed against the Employing Entity.
- Plan Benefits are being changed to state that the SHBP shall be designed to comply with the goals set forth in Georgia law, to describe the process by which the board establishes the plan design and to eliminate specific plan provisions.
- **The Claims** Rule is proposed to clarify that the twoyear time period for filing claims is a maximum liability period.

GSRA will present comments about the proposed changes in the Plan Benefits Rule. This Rule proposal appears to allow a different employer contribution rate based upon the member's chosen option, and it further separates Medicare covered retirees from non-Medicare covered members. We will provide additional information before the public hearing.
