# 2023 Legislative Session More Than Half Over; General Assembly to Award Small Bonuses on top of Small COLAs.

So far, the 2023 session has been a mixed bag for ERS retirees. Of course, our highest priority has been to enhance the amount of the 1.5% COLAs we will receive the rest of this fiscal year in the amended FY 2023 budget and in next year in the FY 2024 budget. For the remainder of FY '23, the House added \$14.5 million for a one-time benefit adjustment, and the Senate added another \$10 million. The amended budget has not been settled, including the amounts currently allocated for state retirees. We understand from reports that the combined \$24.5 million, if appropriated and approved by the ERS Board, would pay for a \$500 across-the-board increase to each retiree. For the retiree receiving a median annual benefit of roughly \$20,000, this amounts to an approximate 2.5% bonus. The ERS Board will decide the method of calculating and distributing the one-time payment.

Governor Kemp's recommended funding for FY '24 would support and contribute to a 1% COLA, although the ERS Board has not committed to awarding a COLA of any size. The formula adopted by the ERS Board in 2022, not the amount appropriated, will determine the actual percentage of a COLA, based on a number of factors. Among them are trust fund earnings and the total funding level/percentage of unfunded liability. We have no influence over how the investment markets will perform, but we will continue to work toward the goal of full restoration of the COLA.

Several bills have been introduced that impact us and are making their way through the process. The major ones are:

- HB 70 and SB 20 provide various restrictions on "surprise billing" for medical services. We generally support these bills.
- HB 317 and SB 117 both would allow beneficiaries of retirees' state group life insurance policies to assign some
  of their anticipated benefits to pay for the insureds' funeral services. We join ERS in opposing these bills because
  they single out funeral homes for special consideration and because of the precedents they may set for other
  vendors to obtain similar authorization. This could result in beneficiaries being subjected in the future to more
  unwanted commercial harassment. Unfortunately, both bills are authored and sponsored by legislative leaders.
- HB 285 raises to 10% the percentage of our pension fund that can be placed in "alternative" investments. GSRA has historically opposed this measure and we continue to have reservations about this investment approach for a number of reasons. However, ERS Director Jim Potvin shared with GSRA data showing that ERS-invested alternatives outperformed other securities in last year's market downturn after outperforming other securities during periods of market growth. We are neither opposing nor supporting the measure. We are guardedly optimistic, per Mr. Potvin's projections, that alternative investments may succeed in the future in generating more revenue for our pension fund.
- SB 76 would cap SHBP's copays for insulin at \$35 for a 30-day supply and \$105 for a 90-day supply.

HB 481 by House Retirement Chairman Carson would require public retirement systems to make investments
solely on the basis of maximizing returns within acceptable risk levels and not to use any other criteria such as
social, political, or ideological interests.

So far during the Session this year, the Legislative Team has met with and been received cordially by a number of leaders in both the House and the Senate who have shown support for GSRA's mission of restoring the COLA. We continue to tell the GSRA story and still have many contacts to make.

Twenty-three legislative days have been completed. Crossover Day (Day 28 of the Session) will be March 6. We, and that means ALL of us, have much remaining to do. We anticipate once again providing you guidance on how and when to convince the Governor and your legislators to support our issues.

### Massive Response to GSRA Survey of Members' Economic Conditions

As you know, GSRA sent out a survey on Feb 13 to all our members with email addresses, 4,401 of you. The survey's purpose is to learn the extent to which the dreadful combination of no COLAs and inflation have negatively impacted your lifestyles and in what ways; to learn to what extent and in what manner those of you who initially retired in comfort and dignity were being forced to cut back because you could no longer afford the associated costs. The purpose of this this survey is to provide our story to the governor and legislators in a way that they may feel obliged to honor their commitment and reinstate more of our COLAs

The survey is explained on both our Facebook site and our web page at https://gsra.memberclicks.net/assets/documents/COLA%20Impact%20Survey.pdf.

We have been staggered and deeply touched by the unprecedented, overwhelming response. 1,121 of you, over 25% of those surveyed, have responded as of February 26. 454 of you also provided a narrative describing your plights. While our compilation is in its early stages, we can report that the responses so far have been truly heartbreaking. At least 96% of respondents have had to cut back in at least one area. Almost half of you have had to cut back in at least six areas. Some specific examples are:

- 70% of you have stopped buying certain foods.
- Almost half of you have delayed or stopped getting routine automobile maintenance.
- Almost half have also delayed getting healthcare including dental and vision care.
- 44%, yes, 44%!!!! of you have had to return to work to supplement your eroded, paltry retirement benefits.
- 52% have had to rely on savings, government assistance, or help from family/ friends to get by.

We will provide you the final results of the survey when completed. God bless you all.



### GSRA Announces Raffle for Enrolling in Pension Deduction-Don't Miss Out! By Allan Hill

Any member who is enrolled in Pension Deduction as of April 10, 2023, is automatically eligible to win one of five \$100 prizes. This includes members currently using pension deduction, current members who now pay by credit card or check but who sign up to switch over to pension deduction, and of course, new and lapsed members. Five names will be picked at random and each name picked will win \$100. When you enroll for or change to pension deduction, ERS will automatically deduct \$1.67 a month from your pension for your dues and send it to GSRA. This way, you'll help guarantee GSRA's financial strength from month to month and the security of the Association year after year.

Now is the perfect time for all members who are receiving a pension from the Employees Retirement System to enroll for pension deduction. The Pension Deduction Authorization Form is easily completed, but it is important that you include legible identifying information and your Pension Identification number (PID). If you do not know your Pension ID number (required by ERS), just look at the 1099-R form that you receive from ERS for income tax purposes to retrieve this number. For active members, ERS will not start deducting your dues until your current membership period expires.

Click on the "Join Us" link at the top of the page; click on the "Pension Deduction Form" link or link to: <a href="Pension Deduction Authorization Form">Pension Deduction Form</a>. Complete the Join Us page, then print and complete the Pension Deduction Form.

Renewing Members and Active Members who are changing payment process: On Home page, click on "Pension Deduction Form" link at the top of the page or link to: <u>Pension Deduction Authorization Form</u>. Print and complete the Pension Deduction Form.

### Top of Mind: "You've Got Mail!"

In the January 2023 newsletter, I shared an image of a postcard with a note that new outreach resources soon would be available to our chapters. As your Board, we have been concerned about the impact of the pandemic on GSRA as chapters could not meet due to health concerns. Now groups are getting back together and we want to support chapter leadership in getting formerly active and lapsed members involved again, as well as to help with outreach to recruit new members.

We settled on the idea of sending post cards to prospects as a low-cost, low-tech way to get started in rebuilding at the community level. Many thanks go to the small group of Board members who helped to create the message and layout and to design the processes for providing contact information to chapters.



With postcards now in hand, our thinking is that if we supply them to the chapters, we can help re-boot outreach activities as only can be done at the chapter level.

#### But why postcards?

Drawing from the direct mail marketing (DMM) sector, which includes membership recruitment and development activities, we learned that postcards have long proven to be a cost-effective way to engage with people you want to attract.

#### Advantages of post cards--

- They're brief and get right to the point of a "Call to Action." In our case, we're asking people to join GSRA, right up front and *on* the front.
- They're eye-catching and have a 100% "open" rate, compared to letters in envelopes or emails. People look at them right away instead of saving "for later" or deleting the email without reading.
- They're inexpensive to produce and mail. Postcard stamps are \$0.48 each vs \$0.63 for first class letters.
- You can add a short, handwritten message on the back.

The Board has purchased the postcards to supply to the chapters *at no cost*. We ask that chapters pay for postage and make sure that current budgets are adequate to cover these costs. (If chapters still need to submit an annual budget for 2023 for Board approval, including a line for postage, now is a good time!)

In addition to the cards, we are now able to provide each chapter with **a list of potential members** (from the ERS Opt-in file). The lists we create for you are based on the zip codes associated with the counties covered by the chapters, which we ask you to provide. To identify zip codes for your chapter, we suggest using this easy search tool: Free ZIP code map, zip code lookup, and zip code list (unitedstateszipcodes.org). The easiest way is to search by each county. The tool will return a map with the zip codes assigned to that county.

Once you've identified the counties and associated zip codes, please enter/copy and paste them into an Excel spreadsheet. Then send them to us at <a href="https://newpagsra.com">help@mygsra.com</a>. Webmaster Kevin Burke will create a query to run against the ERS file data. You will need to provide your zip codes only once, unless you add more counties to your chapter's area.

We'll send a report with the prospect names and contact information to your chapter President, Membership Chair, or other designated person.

We also can supply reports of *active members by county* upon request. We ask that when requesting this report, the chapters first verify the main counties covered by their areas. Once we have that information, Rhonda Floyd, our Administrative Assistant, can build and save the queries for use in pulling future reports upon request.

There are extra, unnecessary, columns in the raw report format. We have a template to guide deleting unneeded columns and information and will make that information available with the reports.

We hope that this initiative will pay off quickly and that we'll see an up-tick in numbers of new and renewing members soon. We are not asking chapters for any record-keeping other than to keep a running total of postcards sent and the number of calls, emails or other contacts they receive as a result. This will help us to gauge whether this is an effective outreach strategy.

To all who embraced both the zip code and post card ideas early on, thank you for your support. If you are a chapter leader, this is an opportunity for involving your members to help with getting the post cards out. If you're a member looking for a way to be more involved in chapter life, this could be it! As *everyone* works on outreach going forward, we also and always welcome your questions, comments and feedback on your experiences.

Let's make 2023 the year that GSRA membership really takes off and grows!

# **Incoming Newsletter Editor Profile-Jay Jarvis**



Jay Jarvis is a native of St. James, New York. After his family relocated to Georgia in 1975, Jay completed his bachelor's degree in Chemistry at Georgia College in Milledgeville and earned a Master's in Forensic Chemistry at the University of Pittsburgh before being hired by the Georgia State Crime Lab in September 1979. During his two-year training period, he was working in Atlanta during the investigation of the Atlanta Child Murders. In 1981, Jay was assigned to the new regional lab in Macon and worked there until 1997 when he was transferred to a new laboratory in northwest Georgia. He was promoted to lab manager in 1998 and was elected to a three-year term as a board member on the American Society of Crime Laboratory Directors in 2004. In 2007, Jay was elected to serve on the American Society of Crime Laboratory Directors-Laboratory Accreditation Board, serving as the Board Chair for one year. The organization was responsible for assessing crime laboratories across the United States and several foreign countries for compliance with accreditation standards. During his long career in state government, he was involved in thousands of criminal cases all across the state, before retiring in 2011 with 34 years of service. From 2007 until 2017, Jay served as the Associate Managing Editor of Crime Lab Report, a publication that tackled controversial and complex issues related to forensic science. In 2009, his book entitled Georgia's Crime Doctor: The Story of Herman Jones and the first twenty years of the Georgia Crime Laboratory, was published. In lieu of COLA's, he started his own forensic consulting firm in 2013 and provides forensic services in criminal and civil cases. In addition, he has written articles for Georgia Backroads magazine. He has been married to his wife Debra, a retired educator, for forty years and have twin sons. They currently reside in the Armuchee community near Rome.
