# **GSRA Day at the Capitol – Big Success!**

Months of planning and hard work by many GSRA members and the Georgia County Welfare Association (GCWA) – our partner for the evening Legislative reception – plus outstanding participation by GSRA membership, paid off dramatically on January 25, 2011, GSRA Day at the Capitol. Members from throughout the state braved a cold and wet day to join together in activities designed to honor state legislators for their service and to send a positive message about GSRA members. Well over 100 members attended the day event, with sixty-one members attending the evening Legislative reception.

The day began with the group assembling at 11:00 in a large committee room in the State Capitol. Led

by David Waller and GSRA Event Coordinator, Chuck Freedman, members received a brief orientation and GSRA buttons and name tags. In addition, members received bags for distribution to legislators that included a pen and coffee mug with the GSRA logo and name, the two most recent GSRA newsletters, and an information sheet describing GSRA's purpose, objectives, and legislative goals. GSRA Legislative Committee Chair, Bill Tomlinson, assured that the attendees highlighted their visit by arranging for a group picture with the Governor and First Lady, Nathan and Sandra Deal.

Working in groups and individually throughout the afternoon, GSRA members dispersed throughout

the Capitol and Coverdell Legislative Office Building to deliver the bags to the senators and representatives who represent them, as well as those legislators for whom no GSRA member was present. Based on the earlier meeting, members were prepared to thank legislators for their service and to engage them about the members' issues.

Members were able to see the legislators "in action" when they attended the organizational meeting of the Senate Retirement Committee. Because of limited space, members rotated so that all had a chance to observe the proceedings. As evidenced by the warm recognition given by the Retirement Committee Chairman, Senator Tim Golden, our presence made exactly the impact that we had hoped.

After the committee meeting, members re-engaged legislators as the opportunity arose. Then, at 4:00, those staying for the reception joined other GSRA members at the Blue Room to await the Joint GSRA-GCWA Legislative Reception. Thirty-five legislators attended the reception and were treated to light hors d'oeuvres and refreshments, as well as the perspectives of our members.

During the reception, President Bobbie Jean Bennett presented GSRA's first annual "Legislator of the Year" Award to Representative Howard Maxwell, Chairman of the House Retirement Committee. Rep. Maxwell was a staunch advocate of retirees during the 2010 General Assembly Session and throughout the year. Also, GCWA President, Mary Beth Lukich presented "Friends of Children" Awards to Senator Renee Unterman and Steve Rumford, President/CEO of The Methodist Home for Children and Youth.

The legislative committees are the front line of legislative activity. GSRA coordinators made sure anyone interested could attend the Senate Retirement Committee meeting in the Capitol Building. ERS and other fund administrators were present and were recognized at the meeting. Committee discussion pointed out the fact that retirement legislation must be evaluated for cost and funding before it can even be considered for a vote.

The House Retirement Committee Chairman and other legislators attended the evening reception, which allowed the retirees time for a casual conversation. It was also a fun time to catch up with friends and make new acquaintances; faces I expect to see again in the next meeting or event.

I want to encourage all GSRA members to be involved and supportive of the organization's efforts to keep us informed and, as I saw at this event, efforts to keep the legislators informed about us as well.

# President's Thoughts on GSRA Day

On behalf of the GSRA Officers and Board, I congratulate the members for making January 25<sup>th</sup> a great and memorable day for our Association. Not only did you impress the legislative members with your knowledge, honor and respect, but many of you have reported that the fellowship with other GSRA members challenged you to become more involved.

Of course, there were "glitches" here and there not to mention that the weather was cold and rainy, but the important point is that all of the adversities were overcome by the members. Members have reported that the day was worth the cost and effort expended by them and by the GSRA leadership to demonstrate our resolve to educate the General Assembly of our concerns. Although over 100 members were walking the halls and smiling at legislators – amidst the over 1,000 school children visiting the Capitol that day — the "in & out" visiting legislative offices appeared to be a much greater number. Our GSRA "buttons" on the lapels were very prominent and many legislators were eager to speak to this "new" constituency. Some members' legislators were not available, but the overwhelming majority of members talked either to their legislators or to their office staff. It was especially gratifying to walk into a legislator's office and find the GSRA coffee mug on the desk.

GSRA members became aware of the importance, during the Senate Retirement Committee meeting, of educating the legislators about members' issues. One

of the experienced legislators stated that he was frequently told that the pension benefit was a contractual obligation. He questioned the Legislative Counselor, who is assigned to the Committee, about who or what entity was making promises (contracts) for which the State is obligated. The Counselor explained that the General Assembly, through law and Constitution, is the contractor.

The events of the day demonstrated that we honored and thanked the legislators for their service. Our elected leaders reciprocated by attentiveness and hospitable concern, although they were non-committal about additional funding—as expected. Our activities generated forward steps in strengthening positive relationships with our elected representatives and in our ability to be heard.

Members also gained an insight into the difficulty of having a legislative impact and recognized the importance of having increased membership. It was good to observe the increasing confidence exhibited by the members as they gained experience in talking with legislators. In fact, many members reported that they thoroughly enjoyed the day with the legislators and their fellow members.
