THIRD ANNUAL MEETING A HUGE SUCCESS!

It was 'Standing Room Only' for GSRA's third Annual Meeting on October 21 at the Georgia Public Safety Training Center in Forsyth. Over 500 retirees flooded the large auditorium for the proceedings. In his opening remarks to the crowd, President Claude Vickers reminded everyone of the importance of local chapters and announced that the total number of GSRA Local Chapters has grown to 13 statewide. He asked representatives from each chapter to stand and be recognized. President Vickers remarked after all local chapter attendees stood up that if YOU were not standing with them, it's time for you to join your local chapter. One of the GSRA Board members will contact you and help you to organize a local chapter in your area.

GSRA was proud to feature at this meeting a panel discussion by six 2010 candidates for Governor: Thurbert Baker, Roy Barnes, Ray McBerry, DuBose Porter, David Povthress, and Austin Scott. Candidate Jeff Chapman had planned to appear as well, but was unfortunately sidelined by a case of the flu. Nathan Deal, Karen Handel, Eric Johnson, and John Oxendine had other commitments and could not attend. Our moderator, Rick Wingo, did a superb job of keeping the session on track. The candidates answered questions on issues of the most concern to all state retirees, and thanks to timekeeper Tom Turner, the 2-hour discussion proceeded with great efficiency. We have requested written responses to our questions from all eleven candidates and will make them available to GSRA members as they are received. Generally speaking, the candidates' statements seemed to support retirees' positions on pension and health insurance benefits. Many thanks to all who submitted questions for the candidates, and we especially thank all the candidates themselves for appearing on the panel.

ERS Board Chair Russell Hinton Reports Bad News to Retirees



Russell Hinton, State Auditor, Chair of the Employee Retirement System Board of Trustees and Member of the Teachers Retirement System.

Next on our Annual Meeting agenda was Russell Hinton, Chair of the ERS Board of Trustees, and member of the Teachers Retirement System Board. Mr. Hinton provided background information on the status of the ERS pension fund and stated that the prospects were grim for a Cost of Living Allowance for next year. He is working with the ERS Board of Trustees, however, to explore the possibility of an overall COLA policy for all pension funds administered by the ERS.

Auditor Hinton also explained issues around the court suit, Willis vs. ERS, and why decisions required a relatively long time. He announced that the Board of Trustees had a vacancy and invited suggestions for the member, which will be appointed by the Board of Trustees.

Nancy Goldstein, Division Director of the State Health Benefit Plan Division of the Department of Community Health, was accompanied by Jean Giles of the SHBP and representatives from United Health Care and CIGNA to respond to GSRA members' questions on the latest changes in health benefits for retirees under age 65 and the policy changes for retirees age 65 and older. In addition to the 35 questions submitted to Director Goldstein, GSRA prepared answers to many common questions and distributed them at the Annual Meeting. Minutes—GSRA Plenary Session – October 21, 2009

President Vickers stated that the minutes of the Annual GSRA Meeting of October 15, 2008, had been posted to the GSRA website for members to view and that a copy of the minutes was attached to the plenary session handouts. A GSRA member moved to approve the minutes as distributed, a member seconded the motion, and the members unanimously approved the minutes of the October 15, 2008, meeting.

President Vickers announced that Treasurer Ronnie Mesimer had provided a copy of the Treasurer's report, which was attached to the Plenary Session Agenda. President Vickers made a few remarks regarding the expenses and financial status. A GSRA member moved to accept the Treasurer's report, a member seconded the motion, and the members unanimously approved the motion to accept the Treasurer's report.

President Vickers reported the activities that the various committees had completed. He stated that it was important for the Membership Committee to continue the efforts to create additional local chapters. He also stated that all committees had worked diligently during the year to complete communication articles of interest for the members and improve the website.

Vice President Bill Tomlinson reported on activities of the Legislative Committee. He outlined some of his thoughts regarding actions and legislation that would be appropriate during the next two legislative sessions.

President Vickers introduced Archie McEuen who is heading up the drive to add local chapters of GSRA. McEuen emphasized how important the local chapters are in achieving the GSRA goals and made an appeal to the members for assistance in establishing local chapters.

President Vickers presented GSRA By-Law amendments. He stated that the amendments had been posted to the website and notice provided to the members. A motion was made, seconded, and unanimously approved to approve the By-Law changes as published.

Jerry Crockett, Nominations Committee Chair, presented the nominations for officers and At-Large Board members of the Board of Directors. A motion was made, seconded, and unanimously approved to close the nominations. President Vickers declared the following officers and Board members approved by acclimation

LEGISLATIVE BILLS OF INTEREST

Introduced in 2009 and Available for Passage in 2010

The Georgia General Assembly will convene the 2010 session in January 2010. There are many issues to be addressed by the General Assembly, including the ongoing downturn in state revenues because of the current economic situation. The following table describes bills introduced in 2009 that are <u>still active and could be passed by the General Assembly during the upcoming 2010 Session.</u>
