# COASTAL CHAPTER HITS THE ROAD TO RECRUIT MEMBERS, START NEW CHAPTER IN LYONS

Members of the Savannah Coastal Chapter met in Lyons on September 7 to discuss the need for state retirees to band together in the fight to receive Cost of Living Adjustments (COLAs) to their retirement payments. The meeting was led by Chapter President Allan Hill and chapter members Laura Ryan and Lorr Elias.

Elias and Ryan explained to over thirty people attending the urgent need to increase GSRA membership in every county. GSRA is the only organization working on behalf of state employees and retirees to advocate for pensions and healthcare benefits. They outlined the steps that GSRA is taking to encourage state legislators to reinstate the once routine, semi-annual 1.5% COLAS and preserve affordable health care benefits.

Elias provided a historical overview of the threats to state pensions and COLAS and laid out the effects of inflation since 2009, the last year that retirees received a full COLA, referring to it as "elder abuse." Ryan contrasted the difference of getting an annual bonus compared to an annual 3% COLA: it adds up to a \$9000 deficit over ten years.

Many thanks to everyone who came from Lyons, Vidalia and beyond, to the members of the Savannah Coastal chapter who went, to the twelve new members who joined GSRA, and to the good folks at Chatters Country Buffet Restaurant for hosting the event.

# **Top of Mind: Falling Leaves 2023**

We have made it through a sweltering summer and according to the Old Farmers' Almanac, the autumnal equinox occurred on September 23. So, hello, Autumn! It's understandable that we all tend to lie low during the peak of a heat wave. But now as the temperatures are more bearable, many chapters that may have taken a summer break are getting back together again.

As most chapters typically meet quarterly, planning a "program" for four times a year can be a challenge. In fact, program planning and finding and making meeting space arrangements are specific reasons that people have told me why they don't want to assume leadership roles at the chapter level.

As to meeting spaces, many chapters are able to arrange to use public spaces like libraries at no cost, or with a small refundable "wear and tear" deposit. Many county library systems now have state of the art internet access and connectivity, so adding slide shows or other visuals for presentations is easy. Other groups like to meet at a restaurant for a meal as a part of their meeting. Fellowship is an important part of membership: there is nothing like sharing a meal to bring people together.

Free space is great, but remember, too, that chapter budgets are intended to support the cost of meetings and activities. As everyone reviews and prepares their budgets for 2024, do keep that in mind. (By the way, we ask that chapters submit their budgets for the next year to us in November.)

Over the last year, I've either attended or heard about some of the programs chapters have arranged and they've been quite varied. In addition to inviting and meeting with members of the area's legislative delegation at some point during the year (always a good event if you can arrange it), here are some of the other topics and resources chapters have arranged –

- A Registered Dietician/Nutritionist discussed the nutritional needs of older adults and provided strategies for healthy eating.
- A representative of the Silver Sneakers program presented on safe ways of maintaining fitness, mobility and flexibility as we get older.
- An elder law/estate planning attorney discussed advanced planning to protect assets and benefits and to assure that families members know each other's final wishes, both for their healthcare decisions and the intention for their assets.

- An AMBA representative shared with one chapter how to get the maximum benefit from AMBA services and discount programs.
- A volunteer from the local Alzheimer's Association Chapter, who also was a family caregiver, present a professionally produced video on recognizing the early signs of cognitive impairment, how the disease progresses and how to cope with the stresses of being a caregiver. This program was outstanding.
- A representative from a county's Beautification program made a presentation to one chapter. This sounds like a good topic to encourage getting involved or staying involved in the community.
- A chapter hosted a member of the regional Area Agency on Aging staff who shared information about services available to older people through the statewide Aging Services network.
- Some chapters get together at least once a year for purely social gatherings, for a picnic, lunch or other meal, just for fellowship. No "program" planning required unless you're having a potluck!
- In several areas, chapter members have gathered to address our Membership Outreach postcards. "Many hands make light work!"
- And, this fall one chapter plans to branch out to a different location in their area to hold a morning coffee outreach event for potential members.

Georgia is a resource-rich state in many ways. The state is blanketed with colleges and universities (<u>List</u> of Universities in Georgia, Map of Georgia Universities and Colleges (mapsofworld.com) and technical colleges (<u>TCSG</u> <u>System Map Sep 2022</u>) that may be sources of program content and presenters. The UGA Extension Service (<u>Programs and Services | UGA Cooperative Extension</u>) offers community education on a variety of topics. And this may be a stretch for some, but this fall would be a perfect time for a field trip on one of Georgia's "Georgia Grown Trails," the Agritourism trails and places of interest established by the Georgia Department of Agriculture (<u>Home | Georgia Grown Trails</u>). Let your imagination out of the box and see what's available!

As we enjoy the crisper days and nights of Fall, don't let program planning be a barrier to pulling your group back together if you've taken a summer break. If you're a chapter leader, consider reaching out to other leaders around the state to find out what has worked well for them. And, above all, ask your members what interests them, what topics they would like to have for a program. You can't go wrong with member input. And, members, speak up! Don't be shy about making suggestions for programs! We're all in this together.

Prior to lunch from Bradley's BBQ in Covington, members socialized and enjoyed catching up on news. President Taylor welcomed the group and invited everyone for lunch.

After more socializing during lunch, President Taylor began the meeting and welcomed the guest speaker, Mrs. Laurie Riley, Manager, Keep Newton Beautiful. Chapter Secretary Janis Tidwell then introduced Mrs. Riley with a brief biography including educational background and noting her twenty-nine years of service to Newton County.

Mrs. Riley began her presentation with an overview of Keep Newton Beautiful and surrounding counties with the same or similar programs. She then did a member participation demo which was educational, interesting and fun. The demo illustrated the effects of individual as well as business and industrial impacts on ground water including two primary types of ground water pollution (one source identifiable and the other source unidentifiable or difficult to identify.) Her presentation demonstrated how easily polluted ground water seeps into creeks, streams and rivers and the ripple effect as well as how we can act to prevent and stop water pollution.
